#### **Political decisions**

- City council resolution "Ban on wood from tropical forests"
- Resolution of the procurement committee in December 2009 "Social and ecological criteria shall be included in public procurement. As far as possible no products from exploitative child labour."
- City council resolution in May 2011

  Accession to ICLEI und Procura+"
- Resolution of the administration and finance committee in November 2011

#### FAIR TRADE - Food

#### Application to become a Fair Trade Town (resolution in November 2011)

#### The following criteria have to be met:

- Fair Trade coffee in the sessions of the city council and meetings of the mayors
- formation of a local steering group to coordinate the activities
- offer of FairTrade-approved products in local retail trade, cafés and restaurants
- use of Fair Trade products and accordingly education activities in public institutions (schools, organisations, churches)
- at least four press reports in the local media each year



#### FAIR TRADE - Food

#### **Application to become a Fair Trade Town**

- steering group: representatives of non-governmental organisations as well as of parties
- award of the title at the end of November
- positive effects: the steering group will continue its work; that means:
  - raising awareness for the basic problems (violation of human rights)
  - spreading the ideas of fair trade within the urban society (e.g. initiating projects in kindergartens and schools, convincing parents)
  - fair trade as a permanent process



#### **Employment of disadvantaged people**

# New canteen in the city administration

- Apart from ecological demands as for example regional and seasonal food the tenant is obliged to employ elderly and disabled people and people who normally have difficulties in finding a job
- Legal basis: within the framework of award of a service concession:
   direct award of contract is possible



#### FAIR TRADE - Food

#### New café in the newly constructed House of Music

- Legal basis: award of a service concession
- a business start-up should be preferred to an established service provider
- besides: regional, biological and Fair Trade products were required
- the concession was awarded to a newcomer with an extensive biological, regional and Fair-Tradeconcept



#### **Procurement of stones**

# Stone Bridge: Renovation and preservation (2011 - 2016)

- demand of the city council and the historic monuments office: renovation close to the original
- Stone samples (quality, colour) were compared to stones
   from different quarries
- stipulation: firms are only allowed to buy stones from three regional quarries that meet the requirements concerning the quality and colour of the original stones
- benefit: no stones from exploitative child labour





#### **Employment of disadvantaged people**

#### **Archaeological and conservation-related excavations**

- Employment of the staff of the non-profit-making organisation "Werkhof"
- salary 22,- €/ hour
- elderly and partly disabled staff or staff who is otherwise difficult to employ
- award without publication of a notice of invitation to tender of a works contract: prime opportunity or advantageous tender -> because of work interruptions local staff is more flexible must be ready on call
- benefit: integration of disadvantaged people in their own region
