Interventions on the 10YFP/One Planet network

Elliot Harris

(23:15): "Again, it {SCP} is at the very heart of the sustainable development agenda. It enables all of the various SDGs. In short, we have no hope in succeeding in the sustainable development agenda without sustainable patterns of consumption and production. And yet the transition to sustainability in consumption and production remains a challenge. At Rio+ 20 in 2012, member states adopted the 10-Year Framework of Programmes to facilitate this transition, recognizing the need for targeted action and support."

Nur Rahayu - Indonesia

(26:05): "In November 2015, Indonesia was confirmed as the new 10 Year Framework of Programmes on Sustainable Consumption and Production Patterns, continuing it's first term as regional representative. This shows that Indonesia has a strong commitment to the worldwide SCP agenda."

<u>Jane Nyakang'o – ARSCP</u>

(44:54): "It [The African Roundtable on Sustainable Consumption and Production] is the principle technical institution tasked with the further implementation and development of the 10 Year Framework of Programmes on Sustainable Consumption and Production"

(46:20): "And just this year we completed the review of our African regional roadmap on the **10YFP**. That document was reviewed to align the African agenda 2063, and it has projects and activities that we as a continent are trying to implement."

(48:20): "We find that the **10YFP National Focal Points**...who are providing the leadership in the implementation of the 10YFP."

(50:35): The global 10YFP Secretariat, we need much stronger linkages between these institutions.

Ulf Jaeckel

(57:40): There is a 10-Year Framework of Programmes on Sustainable Consumption and Production which was decided in the Rio 2012 declaration as a global implementing mechanism on SDG 12, as it is addressed in target 12.1. There is a global structure, with a secretariat at UN Environment, a Board, which I have the pleasure to share, representing the UN regions. There is a trust fund, there is a clearinghouse mechanism, and there are more than 130 National Focal Points, which provide the link to the national level. And most importantly of course, there are six programmes. And these programmes are the places where the work on the ground is done, and there are more than 600 institutions involved. There are many initiatives, for example in the Consumer Information programme, there was the development of guidelines providing sustainability information to avoid greenwashing and showing what are best practices in informing consumers. So, there is a good structure on the global level.



(59:28): Sustainable Consumption and Production is a huge wheel which turns slowly and everyone is affected and could be involved. The 10-Year Framework of Programmes structure therefore was reviewed in its midterm. And taking the results from this review, the One Planet network was initiated, to ensure better participation of all stakeholders and to better foster cooperation. And a new strategy, One Plan for One Planet was developed to ensure even better implementation of SDG 12 over the next five years. The strategy and network clearly focus on implementation. The review showed that in the last 15 years national policies and instruments on the shift to SCP have been increasing in all regions. Prioritizing implementation, fostering application of existing knowledge and tools, scaling up improved practices is needed now to effectively achieve the implementation of SDG 12. The One Planet network is a good mechanism in this regard. The network provides tools, instruments, information on experience over the last five years, facilitation of cooperation, and of partners and support for your contribution for the shift to SCP, sustainable consumption and production. Working with the One Planet network will help all the stakeholders including governments, and others, to do their job on the shift to SCP.

(1:50:18): "The principle challenge is changing the scale, and engaging all stakeholders. At the international level we support the idea which was already expressed, that the 10YFP, and its One Planet network are key tools for creating this dynamic."

(1:53:34): "In 2012, we member states agreed on a 10-Year Framework of Programmes, to guide, promote and support the shift to towards SCP, providing an effective platform for engaging key stakeholders, from consumers to corporations, to be the actors of change."

(1:54:05): "Today, five years into the 10YFP, we are launching the One Planet network, further strengthening this global effort towards SCP."

(2:17:08): "UN Environment and the **One Planet network** established to implement the 10-Year Framework of Programmes on Sustainable Consumption and Production Patterns are working to demonstrate and communicate the benefits of SCP and to mobilize the necessary political and financial support."

(2:17:26): "It's not a question of persuading countries to request support from the **One Planet**Network, it is the ability of that network to deliver that support on the ground. We are now able to show gains..."



(2:18:14): "We need more support to implement the **One Planet network five-year strategy** that has already been mentioned. We are sure that UN Environment and the 700 partners in the **One Planet network**, including government, business, civil society, and the major groups, and many others in this room and institutions represented here will support and engage in this new strategy. This will also enable the achievement of many other SDGs and the Paris Agreement."

Uganda

(2:42:33): "SCP is very unique in that it has the 10YFP programme. It is the only SDG with a global coordination mechanism."...In the context of the Africa region, we had a very robust roundtable arrangement, at the regional level, at country levels, and I think this is where the The 10YFP should come and support us...Now that we have the One Planet, I would like to look at the agenda, and see if it listens to some of the areas, or methods of interventions that we think will produce results in this region."
