Australia

"Australia supports the United Nations 10- Year Framework of Programs on sustainable consumption and production – elements of this framework are reflected in the National Waste Policy and Product Stewardship schemes." (Australia VNR Full Report, p. 83)

Hungary

"Hungary played an active role in the elaboration of the 10 Year Framework of Programmes on Sustainable Consumption and Production Patterns (10YFP) and took part in voluntary sustainable consumption and production pilot reporting in 2015 and 2017. The delegate of the Ministry of Agriculture has been representing the Eastern European Region on the Management Board of the 10YFP since 2017 and also as a member of the Strategy Task Force." Jamaica

"A major catalyst forthe global pursuit to ensure SCP patterns has been the 10Year Framework of Programmes on Sustainable Consumption and Production Patterns (10YFP) that emerged out of the Johannesburg Plan of Implementation (JPOI) at the World Summit of Sustainable Development (WSSD). Jamaica participated in the first meeting of the Executive Committee of the Regional Council of Government Experts on Sustainable Consumption and Production for Latin America and the Caribbean in 2014, out of which emerged a new Regional Strategy and Action Plan 2015–16 for SCP. Notably, a concrete outcome from this regional strategy has been the focus on supporting Small and Medium Sized enterprises in meeting the goal of sustainable consumption and production in LAC. Jamaica is also among 20 countries in the region which has appointed a 10YFP focal point which sits at the National Environment and Planning Agency. De 10YFP Trust Fund is one of the means of implementation of the 10YFP which seeks to provide support to assist developing countries and countries in transition to advance towards SCP patterns." Romania

"Romania was a very active member of the UN Open Ended Working Group on elaborating the SDGs, as well as member of the Board of the 10-Year Framework of Programmes on Sustainable Consumption and Production Patterns (for 2 mandates)." (Romania VNR Full Report, p. 7)

"Romania has contributed to the adoption of the 10-year Framework of Programmes on Sustainable Consumption and Production Patterns (10YFP) leading the international process that agreed ad referendum the document, respectively the 19th Session of the UN Commission for Sustainable



Development (CSD19) one year before the adoption of 10YFP at Rio+20 Conference in 2012. On reaching the 12.1 target, Romania, as member of 10YFP Bureau for 2 mandates from 2013 to 2017, chaired the First 10YFP multi-stakeholder Regional Meeting for Eastern Europe, held on 27 October 2014, in Geneva, Switzerland and organized the Second Multi-Stakeholder Meeting of the 10YFP for Eastern Europe, 9-10 February 2016 in Bucharest". Spain

"Sustainable consumption and production will be promoted through the implementation of appropriate strategies, policies and regulations. The 10-Year Framework of Programmes on Sustainable Consumption and Production Patterns (10YFP), proposed at the Rio+20 Conference, is being applied through a package of measures spanning the five programmes included in this framework." Switzerland

"Switzerland's international efforts in relation to SDG 12 concentrate on: i) promoting the green economy by helping to develop harmonised international rules, supporting the UN's 10-Year Framework of Programmes on Sustainable Consumption and Production Patterns, and activities within the framework of the international conventions on waste and chemicals". Sri Lanka

"The MMDE has taken the leadership in preparing the draft National Policy on Sustainable Consumption and Production which provides overall guidance with regard to sustainable consumption and production aspects in all economic sectors... In this line, the Ministry serves as the national focal point for the implementation of the 10-Year Framework of Programmes of Sustainable Consumption and Production (10YFP) carried out by the United Nations Environment Programme (UNEP) (Targets 12.1 and 12.2)."
