With Climate Crisis & DRR : Unfortunately Furry of cyclone Amphan happened in between that accelerated more risks, miseries & vulnerability. Despite all adversity, community understanding and mobilisation process has added enough strength to become resilient and adaptive toward disease and disasters.

Fact that COVID-19 disaster has made everybody leveller & grossly impacted as whole & risk is systemic, and crises are cascading. Everyone is affected, but not everyone is affected equally. The elderly, people living with disabilities, resource poor , women, children ,migrant workers and the poor and marginalised are most vulnerable.

COVID-19 & climate crisis both are rapidly producing further disaster to become more complex and deadly. The Indian State of Odisha, [considered as one of the backward states in human development index](#), has been grossly impacted by COVID-19 & recurrent climate crisis . Development has pushed back more than a decade because of recurrent shutdown and lockdown for which huge work force was stranded that has accelerated poverty and inequalities & distressed migrants .Not only Industries, but Schools , education institutes closed because of psycho-fear of spreading & scaling the transmission of virus that created a fear syndrome. But large section of communities has survived, showed the pathways.

Learning from ground with community is that it needs regenerative livelihoods, quick engagements in productive work to grow food, water, nutrition and immunity boosting naturally. The solution lies in nature based prevention followed by protection and provision – increasing readiness to address the corona virus crises and reducing the impacts of future climate risks & disasters. Looking at COVID-2019 & 2020 and current vulnerabilities, there is a dire need for short- and long-term actions to promote sustainable, resilient livelihoods that can cope with the forthcoming climate crisis in order to make sustainable communities.

The issue is health care to save lives but fighting hunger, poverty, hygiene, Malnutrition, WASH, Immunity boosting, inequality are major grey areas that



have exacerbated the COVID pandemic situation more multifaceted. Post Covid management has become so hard & harsh that the impact for recovered patients have been facing so difficult times . Cases revealed that impacted persons have been died before CORONA kills due to lack of immunity despite well vaccination for second dose which has highlighted because spread & community transmission.
