


## Dear all,

United Nations Environment Assembly (UNEA-6)



Türkiye's Ministry of Trade and the Netherlands' Ministry of Infrastructure and Water Management are organizing a UNEA-6 side event on "Connecting the Threads: A coordinated policy response to transform the textile value chain and offer solutions which preserve nature". The event will focus on systemic issues in the textile sector, exploring environmental and social impacts throughout the value chain. It will offer a platform to discuss coordinated policy responses and solutions for transforming the textile value chain while preserving nature. Publications and Resources



The Joint Research Center of the European Commission published its report "Techno-scientific assessment of the management options for used and waste textiles in the European Union," which summarizes the scientific knowledge on recycling, recovery, and disposal options for waste textiles, highlighting the dominance of incineration and landfilling, the emerging closed-loop recycling facilities, and the costeffective and environmentally favorable nature of re-use. In 2023, the Copernicus Institute of Sustainable Development released three white papers offering practical recommendations for businesses in the textile value chains of India, the Netherlands, and Spain. The reports focus on Circular Strategies and social impacts, outlining actionable

steps for companies in each country.

Additionally, they published a book excerpt "Circular economy in the textile and apparel sector: an overview of global trends, challenges, and opportunities."

Ramesh De Silva's report, "Repair as a Best-Practice in Reducing Pre-consumer Industrial Fashion Waste," sheds light on the staggering scale of the \$1.8 trillion global textile industry. The report highlights the issue of pre-consumer waste, suggesting that up to 47% of fiber in the fashion value chain becomes waste, and advocates for garment repair as a circular business model, as repairing garments not only extends their life but also conserves resources, significantly reducing CO2

emissions, water usage, electricity, and waste. You can find the report here.



In December 2023, the Policy Hub, in collaboration with 2050, published "Threads of Change: Exploring the EU's Patchwork of Climate and Textile Policies." The report identifies climate vulnerabilities in the textile sector for both the EU and globally, outlining opportunities for decarbonization through existing EU policy instruments. Designed for policymakers, it provides a toolkit for coordinating and integrating climate action through regulatory and financing mechanisms for the apparel and footwear sector. UNEP's Regional Office for West
Asia's West Asia Sustainable
Fashion Academy, developed with
the support of GO4SDGs, has
introduced the West Asia
Sustainable Fashion Accelerator.

The accelerator aims to collaborate with emerging and established fashion designers in the West Asian region, addressing technical, commercial, and creative challenges in implementing sustainable practices. The pilot cohort included five designers who created exclusive looks for Haya Magazine, applying scalable system thinking and circularity strategies with one-to-one training sessions. 






Join the UN Alliance for Sustainable
