All countries should promote sustainable consumption and production patterns (...) all major groups should play an active role in changing unsustainable consumption and production patterns”*

- **The 10YFP was adopted at the Rio+20 Conference.** It is a global framework of action to enhance international cooperation to accelerate the shift towards SCP patterns in both developed and developing countries.
- It supports **capacity building** and **provides technical and financial assistance** to developing countries for this shift.

- Consumer information
- Sustainable lifestyles and education
- Sustainable public procurement
- Sustainable buildings and construction
- Sustainable tourism, including ecotourism
- Sustainable food systems




10YFP SPP: Regional distribution of the programme's partners

Revised 10YFP SPP Programme biennial work plan 2016-2017







Wide-reaching Procurement Strategy reflects Auckland Plan priorities and sets out 6 principles:

1. Work together
2. Value Te Ao Māori (Māori world)
3. Be sustainable
4. Act fairly
5. Make best use of every dollar
6. Be affordable

Mandatory for all procurement to align with strategy so council can use the power of its significant budget for transformational change.

Organisational performance targets for procurement

- Auckland is committed to having an embedded Smart Procurement Framework that matches all categories purchased to relevant sustainable outcomes
- Zero waste by 2040
- Greenhouse gas emissions (tCO2e) reduced to 27,475 by 2019

Category performance targets for procurement

- All organic material is either composted or recovered into heat or energy by 2040
- City Rail Link project – target an Infrastructure Sustainability Council of Australia (ISCA) Infrastructure Sustainability (IS) 'Excellent' rating with aspirational goal of zero waste to landfill, and shared learnings
- Energy efficiency and conservation will be improved by supporting the retrofitting and redevelopment of residential, commercial and industrial buildings
- Deliver LED Streetlight retrofit Stage 1 programme and plan for Stage 2 by 2018
- Road maintenance contracts to report on energy & waste and highlighted areas for improvement by 2017
- By 2020 reduce the unemployment rate as well as the number of 16-24 year olds not in education, employment or training
- Improve upskilling, reskilling and life-long learning in workplaces by 2022
- Increase the number of women-, Māori- and/or Pasifika-owned businesses and social enterprises engaged through direct contracts or supply chains by 2019
- Social Outcomes as a weighted attribute in applicable procurements by 2018

Operational performance targets for procurement

- All procurement staff will receive training on the Smart Procurement Framework by 2017
- Smart Procurement guidance will be available to all staff on the intranet by 2017



- ISO14001 environmental management system (EMS) outcomes specified for project
- Council worked with contractor to implement ISO14001 EMS
- Now implementing ISO14001 system for actual operations of occupied building

- Target of Infrastructure Sustainability Council of Australia 'Excellent' rating within each contracted phase of works

- Incorporation of Mana Whenua cultural narratives in station architecture
- Collaborative workshops with contractors to improve sustainability performance of project design

Current Workstreams: Procurement Process

- Nearly all departments and divisions interact with procurement processes at some stage
- Embedding smart and sustainable principles within procurement an opportunity to educate and enable staff to think differently and deliver more broadly on sustainability
- Currently looking at mechanisms to integrate this thinking earlier in project design to deliver wider and better social, economic and environmental outcomes

Current Workstreams: Social Procurement

- Social outcomes identified as significant opportunity in procurement
- Potential to provide training and employment for low-income and at-risk Aucklanders alongside project delivery
- Potential to encourage and enable innovative social enterprises
- Focussed work on social benefit capture via frameworks like [Social Return on Investment](#), and [Buy Social](#)
- Importance of tailoring frameworks to integrate Māori world view and cultural diversity key to local buy-in

Impact and mainstreaming Low Carbon Procurement in Practice

In a nutshell...

The overall objective of GPP 2020 was to

- **significantly increase** the implementation of GPP within the target countries
- both in the **short** and **long** term
- through a series of **capacity building** and
- **major tendering** actions.

Implemented from May 2013 – April 2016 by 17 partners (8 purchasing bodies, 8 national support partners and one coordinator)



Impact

113 GPP tenders for energy related products and services carried out – documented in Tender Models

Estimated savings (only by tenders, not including capacity building programme): **922,932 t CO₂e**

Training seminar series with **670 people** trained, both train-the-trainer and train-the-procurer seminars

Further support activities in each country: training, **7 helpdesks**, networking events, guidance, webinar series, engaging with more than **50 associate partners**, etc.

CO₂ procurement impact methodology and **4 calculators** developed (all online, incl. video tutorials): Vehicles, ICT, Street Lighting, Energy Performance Contracting




Green public procurement in Croatia

At the start in 2013:

- Just a few green tenders done in Croatia by individuals
- GPP = more expensive (avoid)
- Lack of promotion of GPP
- No GPP action plan
- No institution providing GPP trainings to procurers
- No Croatian examples (case studies)



Step 1 : Including “major players” in the project

GPP 2020 in Croatia had 10 partners including:

support partner and PB**

HEP LTD – PB (26. largest company in Balkan area)

Central procurement office – PB

Zagreb Holding- PB

2013 - Only 1 tender in Croatia done – difficulties in engaging the procurers to implement GPP criteria

2014 - First trainings done , promotion ongoing : 5 tenders done

2015- Croatian case studies published , completed all the trainings,helpdesk launched , procurers feel more comfortable in implementing GPP criteria : 8 tenders done

2016 - 4 tenders

2016- 5 additional tenders done AFTER project ending

Most successful criteria: Energy contracting replicated by 5 other municipalities(not in the project)

18 tenders implemented by 10 different partners

More than 150.000,00 tonnes of CO2 saved




GPP 2020 impact:

- **Developed first Croatian helpdesk for GPP and successfully transferred to Ministry of Environmental and Nature protection**
- **Trainings for procurers – programme successfully transferred to State school for public administration - 2 trainings done outside GPP2020**



- 15 case studies with Croatian examples and GPP calculators for replication - no longer “it can’t be done” attitude ,
- GPP national action plan developed
- GPP a hot topic (over 20 000 visits)
